MLADIĆ case

Trial Chamber I – Judges Orić (Presiding), Moloto and Flügg

Pre-defence Conference

On 12 May 2014, the Pre-Defence Conference took place, during which it was announced that Mladić Defence was granted 207, 5 hours to present its case, which will commence on Monday, 19 May 2014.

ORDER ON THE REGISTRAR'S APPLICATION PURSUANT TO RULE 45(E) OF THE RULES

On 13 May 2014, the Appeals Chamber granted the application by the Registrar and ordered Slobodan Praljak to reimburse the Tribunal the amount of 2,807,611.10 euros within 90 days. The appellant is allowed, if he so wishes, to repay the amount in monthly installments over 3 years, in which case he will have to pay 10% within 90 days and after that approximately 70,000 euros every month.
