MOTION TO AMEND THE FIRST AMENDED INDICTMENT

On 22 September 2008, the Prosecution filed a motion to amend the current indictment against Radovan Karadžić and submitted a proposed (second amended) indictment.

DECISION ON NIKOLIĆ MOTION FOR ISSUANCE OF A SUBPOENA

On 23 September 2008, Trial Chamber II reaffirmed its oral decision granting a motion by the Defence of Drago Nikolić and issued a subpoena ordering witness 3DW-18 to appear in the court and give testimony on 2 October 2008 or on a date and time to be notified.

DECISION ON VUJADIN POPOVIĆ'S INTERLOCUTORY APPEAL AGAINST THE DECISION ON THE PROSECUTION'S MOTION TO REOPEN ITS CASE-IN-CHIEF

On 24 September 2008, the Appeals Chamber dismissed an appeal by Vujadin Popović against the decision granting the Prosecution's motion to reopen its case.

DECISION ON PROSECUTION'S MOTION FOR JOINDER AND FOR LEAVE TO CONSOLIDATE AND AMEND INDICTMENTS

On 23 September 2008, Trial Chamber II granted in part a motion by the Prosecution and ordered that the case of *Prosecutor v. Miće Stanišić* and the case of *Prosecutor v. Stojan Župljanin* be joined and instructed the Registrar to assign a common case number. The Prosecution was ordered to file the amended consolidated indictment within seven days. Pursuant to Rule 50(B), both accused shall be given the opportunity to enter a plea on new charges in due course.
