#### **DECISION ON NOTICE OF APPEAL**

On 9 January 2003, the Appeals Chamber dismissed the Defence Notice of Appeal from the Judgement concerning the Defence Motion Challenging the Exercise of Jurisdiction by the Tribunal, filed on 7 November 2002.

Judge Shahabuddeen appended a Dissenting Opinion to this Decision.

#### **ORDER SUMMONING DR. BILJANA PLAVŠIĆ *PROPRIO MOTU* TO APPEAR AS A WITNESS OF THE TRIAL CHAMBER PURSUANT TO RULE 98**

On 9 January 2003, the Trial Chamber ordered Biljana Plavšić to appear as a witness before the Trial Chamber as soon as practicable following the delivery of the Sentencing Judgement against her or, if she wished, at any time before the delivery of the Sentencing Judgement.

The Trial Chamber further ordered that the scope of the questions asked by the Prosecution and the Defence be limited to the scope of Biljana Plavšić's statement and the Judges' questions.
