Vojislav ŠEŠELJ Case

Judge Pocar – President of ICTY

DECISION ON APPEAL AGAINST DECISIONS OF THE REGISTRY OF 20 AUGUST 2004 AND 30 JANUARY 2006

On 11 April 2006, Judge Pocar dismissed V. Šešelj's appeal, dated 28 February 2006, against the decisions by the Registry to ban the visits of Tomislav Nikolić to the accused in the Detention Unit, filed on 20 August 2004 and subsequently on 30 January 2006.

DECISION GRANTING PROVISIONAL RELEASE TO HARADIN BALA TO ATTEND HIS DAUGHTER'S MEMORIAL SERVICE

On 20 April 2006, pursuant to Rules 65 and 107 of the Rules, the Appeals Chamber granted the urgent motion of Haradin Bala to attend a memorial service in Kosovo on 26 April 2006 in honour of his daughter, who had died on 18 April, and to spend the period of 21 April to 27 April 2006 in Kosovo with his family and members of his community during the traditional period of mourning before the memorial service. The motion was granted subject to a number of conditions set forth in the decision – *See Press Release, number 1070, dated 21 April 2006.*
