#### ORDER CONFIRMING OJDANIĆ WITHDRAWAL OF REQUEST FOR RULE 54**bis** ORDER TO UNITED STATES OF AMERICA AND NORTH ATLANTIC TREATY ORGANISATION

On 23 April 2007, pursuant to Rules 54 and 54**bis** of the Rules, the Trial Chamber confirmed the withdrawal of the Ojdanić Defence motion for binding order to the United States, NATO and General Wesley Clark. The Defence filed the motion on 2 April and then withdrew it on 23 April 2007.

#### DECISION ON REFERRAL OF CASE UNDER RULE 11**bis** WITH CONFIDENTIAL ANNEX

On 27 April 2007, pursuant to Rules 11**bis**, 54, 75, 82 and 127 of the Rules, the Referral Bench granted the Prosecution motion for referral, filed on 4 May 2006, and ordered that the case of *Prosecutor v. Trbić* be referred to the authorities of Bosnia and Herzegovina, so that those authorities may forthwith refer the case to the appropriate national court for trial within that state.
